Subject :- Unauthorised absence from duty and suspension thereof.

ORDER NO: 670 CAD/2016

DATED: 26. 12. 2016

1. Whereas, the Headquarter Assistant to Deputy Commissioner Leh conducted surprise checking on the direction of the Deputy Commissioner Leh to the office of Command Area Development Department on 26.12.2016 at 1.15 pm.
2. Whereas, while checking the office of the Command Area Dev. Office, Leh, it is found that Sh. G. M. Khan, Deputy Director, CAD has remained unauthorisedly absent from duty and has left the station without prior permission from this office.
3. Whereas Section 38 read with Section 39 of the LAHDC Act 1997 make all Govt. employees of District Leh Subordinate to the Deputy Commissioner (Chief Executive Officer, LAHDC, Leh) and in this capacity it is the responsibility of this office to ensure that Govt. Institutions like Command Area Dev function properly.
4. Whereas, being the Deputy Director of the Command Area Development, it is the responsibility of Sh. G. M. Khan to manage its affairs in a professional manner. However, such an irresponsible act of the officer amounts to supervisory lapse including negligence of duty.
5. Whereas the officer was in practice to remained absent and leaving the station without permission in past also. For which this office sought an explanation vide this office No. CAD-6(M)E/16(201) dated 12.8.2016, in response to which, the officer apologized and ensure that he will not leave the station without seeking proper permission in future.
6. Whereas in the instant case the Addl. Deputy Commissioner, Leh shall hold an enquiry into the matter.

Till the outcome of the enquiry Sh. Sonam Angchok, District Agriculture Officer (Extension) who is holding the addl. charge of Asstt. Soil Conservation Officer, CAD shall also hold the charge of Deputy Director, CAD in addition of above.

Now, therefore, keeping in view the serious negligence the following action is hereby ordered:-

- a) Sh. G. M. Khan, Deputy Director, is hereby placed under suspension with immediate effect and attached to the office of the Deputy Commissioner Office, Leh. The memorandum, article of charge and statement of imputation, in support of article of charge shall immediately follow.,
- b) The drawal of salary of Sh. G. M. Khan for the period of suspension shall be dependent on authorisation by this office. Accordingly, the District Treasury Officer, Leh shall withheld the release of salary of the officer till further directions by this office.
