
Interested/deserving candidates shall have to submit online application by or before 15th November 2017 on KVIC, national web portal "www.kviconline.gov.in" and submit hard copies of application to the General Manager, District Industries Centre, Leh during working hours.

The eligibility criteria for the scheme is as under:-

1. **Qualification.**
Minimum 8th pass.
2. **Age :** 18 years and above.
3. **Nature of Financial assistance.**
The rate of Margin Money subsidy on the financial assistance is 25% for urban and 35% for rural areas with 5% own contribution for reserved and 10% of General category.
4. **Downloaded application form shall be supported with following documents.**
 1. Aadhaar card (Mandatory)
 2. Age and address proof.
 3. Unemployed and identifications certificate (Gazetted Officer)
 4. Affidavit (on prescribed format)
 5. Qualification and experience.
 6. Passport size photographs.
 7. Details of machinery to be installed.
 8. Training certificate (if any)


